Went to sleep last night at 3:30 AM because  
Joselito was restless and agitated. Woke up at 10:00 AM.  
Called up Mr. V. Abad Santos on the de la  
Cavara case pending before Judge Euage of Butuan  
City so that Mr. Abad Santos may by administrative  
order transfer all criminal cases for crimes committed  
within the jurisdiction of the new province of  
Agusan del Sur. This would transfer the de la Cavara  
case to a court other than Judge Euage's who is  
prejudiced against de la Cavara and according to  
Mr. Abad Santos even conspired to harm de la  
Cavara. Judge Euage lives like a king. He  
has a big house in Macau and lives it up in  
Butuan. He ordered a million pesos more, still bond  
for de la Cavara. And notwithstanding the decision of the  
Supreme Court refuses to lower it.

So de la Cavara has misgivings about our  
rendering to Judge Euage. He would rather go back  
to the mountains where his tribe is all accomplish the  
mission we have for him in the NPA.

Then I talked to Cong. Yuang to talk to  
Judge Euage to follow the administrative order to  
transfer all the criminal cases of Agusan del Sur  
to that province. He claims he has lost control

of Judge Eusejo who is now arrogant, refused to see Cong. Grigorey the last time the latter went to his house, but he will make one last effort next Saturday.

Worked on the position paper for the U.S.-Phil. Air Agreement negotiations in Washington at the end of the month. We reject the Bermuda principle to the effect that the airline operators can fly any number of flights in the route and carry any number of passengers. We maintain the power of the local CAB to control flights and passengers.

This noon the Mauglans committee on Electoral Suffrage voted down by 19-14 the motion to delete from the report the Ban-Marcos provision. But there are still at least five who had not voted or desisted and have up to about 10:00 AM to cast their votes. The boys, Bribit Duwart, Baby Favaro and Yerza are working on the statements through Jimmy Opinon, Perea through Huno de Vega, Jaled Ogas through Peleg Mito. They are optimistic.

But it really does not matter since the question has to be brought to and decided on the floor of the convention.

The way the media and the political opposition has jumped on us and crucified us on all the issues raised against us. Talantico the Nacionalista majority floor leader of the Senate has turned against us on the transfer of funds.

Sen. Aquino is as irresponsible as ever, treacherous and openly subversive. In the Senate he has falsely charged that over one half of PIA at the other air lines. the revelations of de la Canaria make me

fear for our safety as a nation and as individuals. I am now convinced that even if we retire we will be hunted and killed by the ~~peacefully~~ Communists or the political opposition.

So there may be no other option but to wait until the Communists start their urban operations making it necessary to declare martial law.
